Opening Remarks from the Chair and Vice Chair

Clara Lajonchere, PhD, Chair

- Significant milestones for the CIAPM program, from intentionally engaging philanthropic leaders to injecting equity in expert selection and evaluation committee processes with compensation for the first time.
- Federal attention continues to grow, from NIH institutes to NASEM and industry groups with a sprinkle of international inquiry, and an opportunity to support a UN Commission.
- The pace and volume of CIAPM's portfolio continues to promote cross-sector collaboration, within and well beyond California borders. Council members should attempt to loop staff into opportunities for deeper connection, (ex. Personalized Medicine Coalition connection via Advisor Sakul).
- As will be summarized by Richard Figueroa, the situation with the State budget this year means no new financial investment, but that's not holding back the CIAPM staff from an ever-more expansive approach to its mission, to demonstrate the promise and potential of precision medicine.

Keith Yamamoto, PhD, Vice Chair

- The CA voters and administration have committed to the challenge of engaging the state in scientific work, and the two agencies that carry that effort are mainly CIAPM and CIRM, the regenerative medicine stem cell agency.
- At the federal level:
 - For nearly a decade, the NIH essentially received flat funding, followed by seven consecutive years of robust budget increases from 2-3 billion per year.
 - The FY23 budget was 47.5 billion dollars, and the FY24 budget has just been signed by the President and the NIH absorbed a cut of about 0.8% in this budget for FY24. The President's FY25 budget just was released, and it is projected for an increase of about 2% in the analytics budget over the FY23 budget (amounts to around an \$900 million increase, and around a \$500 million budget increase over FY24).
 - With this funding comes new opportunities and challenges in putting together programs that can move CIAPM efforts forward.

The NSF also carries out substantial biological research, especially in the realm of biological engineering. While they anticipated a large budget increase because of the passage of the CHIPS and Science Act in 2022, which authorized a huge budget increase for the NSF. Instead, the NSF FY24 budget was cut by almost 9%. That is going to have an impact on the national biomedical research effort as well.

At the state level:

- CIRM is undergoing a lot of change as they search for new leadership, including a president.
- CIRM had decided to dedicate \$1.5 billion dollars towards research on neurological disease and neuropsychiatric disease.
- This will lead to new programs and new grant offerings towards basic science as well as translational and clinical efforts.
- This provides an exciting opportunity for CIAPM to be in communication with CIRM leadership to coordinate efforts and potentially develop synergistic collaborations.

Updates from the Governor's Cabinet

Richard Figueroa, MBA, Deputy Cabinet Secretary

- The January budget is a real-time snapshot of expected revenues and expenditures based on data state received in October and November.
 - The legislature must also enact a budget by June 30 via the May Revision, once the complete dataset from November-March is compiled in addition to information from taxes filed in April.
 - The Administration is seeing a slight revenue downturn and is therefore planning to constrain expenses, especially in consideration of our various multi-year programmatic commitments.
- Commends CIAPM in taking on the broader scope of precision medicine beyond grant administration, making greater connections between the California government and the rest of the state, such as the life science industries and CA teaching institutions.
- CIAPM should remain in continuous communication with the legislature, especially because of the large turnover in the legislature every two and four years. Keep current legislature aware of the existence and mission of CIAPM, as well as its connection to other state and federal efforts.

Updates: Demonstration Projects

Cancer Disparities

- CIAPM's three Cancer Disparities projects completed in 2023, and staff have initiated an evaluations process, as required by statute, which is expected to be completed in late Q3 or Q4 this year.
- Evaluation Committee: Three members served on the original 2018 Selection Committee, and three were recommended by Lead Investigators or their networks. Two committee members will evaluate each project.

ACEs Research Projects

- ACEs projects have requested one-year no-cost extensions, which are in process, and projects will now be completed around Summer 2025. Projectspecific webpages are online [link].
- CIAPM staff conducted annual site visits for the seven ACEs projects in Winter 2023/Spring 2024.

 CIAPM continues to seek out opportunities to facilitate coordination and collaboration between ACEs projects, including a plan for a panel submission at a 2025 conference (e.g., American Academy of Pediatrics, Society for Research on Child Development, or Pediatric American Societies).

Depression Research Program

- Overview
 - \$9 million for research demonstration grants, 3-5 projects, up to \$3 million per project, 36-month project period.
 - Competitive grant program to support precision medicine-based approaches to preventing, diagnosing, and treating depression.
 - Projects must be co-led by a CBO or community clinic and include a private sector collaborator.
- Timeline
 - Jan. 17, 2024: Concept Proposal Selection Meeting
 - Jan. 2024: Notification of Finalists
 - o Feb. 15, 2024: Due Full Proposals
 - Spring-Summer 2024: Awardees Announced
 - Summer-Fall 2024: Anticipated Project Start
- Expert Selection Committee
 - Recruited 17 out-of-state experts for the Selection Committee.
 - o For the first time, experts will be compensated for their contribution.
 - Selection committee members and bios are on the CIAPM website [link].
- Selection Process
 - Letters of Intent: 60 total from 25 institutions
 - o Concept proposals: 41 total from 22 institutions
 - Full proposals: 16 total from 8 institutions
 - Expected awardees: 3-5 from 3-5 institutions
- Logistical Updates
 - Finalists propose to develop new healthcare technologies and evidencebased behavioral interventions for minoritized communities, including youth with autism, are at-risk, or who identify as a sexual minority, as well as immigrants and farmworkers, Asian-American/Pacific Islander communities, Middle-Eastern/North African communities, and people with perinatal depression.
 - Instructions for Full Proposals incorporated feedback from September 2023 Council Meeting to include equity and accountability statement.
 - CIAPM is pursuing potential philanthropic partnerships to increase funding capacity and impact across California.

Representative Research Collaborative

The Representative Research Collaborative has established a Memorandum of Understanding with the NIH All of Us Research Program to advance the research program among underrepresented participant populations and researchers in the

Central Valley and Northern California. This growing program intends to use the State's extensive community and researcher relationships to further the mission of NIH's All of Us Research Program. CIAPM intends to disseminate existing All of Us engagement assets to California's diverse population, public university community, and public employees through existing communications streams.

Outreach through State and local public agencies and their networks

- CIAPM Participant outreach responsibilities per the MOU
- Partnering with All of Us consortium members to expand the reach and awareness of All of Us:
 - Primarily focusing outreach efforts related to engagement and enrollment in All of Us on individuals from populations that are underrepresented as participants in biomedical research, especially those residing in the Central Valley and Northern California regions.
 - Exploring and possibly facilitating outreach and engagement campaigns to public employees and/or consumers of state services.
 - Referring interested individuals to All of Us enrollment partners in the region as well as providing guidance to join independently via the www.joinallofus.org webpage.
 - Collaborating with local enrollment partners to increase access to and awareness of enrollment and engagement opportunities with local and national partners in All of Us.
 - Working collaboratively with the DEO Tribal Engagement team to engage the Al/AN Indigenous population in California.

Methods
